Qualifications of the Election to Board of Directors

To run for or hold an office on the Board, a member must be in good standing, have been a member of the organization for a minimum of one year, and will commit to participate in Board Meetings and events and submit an email notification to be approved for nomination by the Board.

Vice-President

The Vice-President shall assist the President in administering the business of the organization and shall preside in the absence of the President and shall succeed to the term of President if the President is unable to serve out the term.

Treasurer

- A. The Treasurer shall assume responsibility for the financial matters of the organization and the exchange of money at all events, including working the check-in table.
- B. The Treasurer shall attend Board meetings and have the books of the organization ready for examination by any member of the Board upon request. The Treasurer will also submit monthly bank statements to the Secretary to be attached to the minutes.
- C. The Treasurer shall present the books annually for inspection by another member of the Board appointed by the President.
- D. The Treasurer shall prepare quarterly reports for presentation to the Board.
- E. Upon leaving office, the Treasurer shall pass on for the present and prior years all funds, records, and books in good order to the President, which will then be audited by a Board appointed person before they are passed on to the new Treasurer.






